Release Summary

The 8.2.1 release notes provide an overview of the US Veteran's Employment Reporting enhancement to Banner® Human Resources and Position Control.

This document provides detailed information about the Human Resources 8.2.1 release only. Human Resources 8.2.1 is an optional regulatory release.

System Requirements

The following minimum releases must be installed to upgrade to Banner Human Resources/Position Control 8.2.1:

- Banner General 8.2
- Banner Position Control 8.2
- Banner Human Resources 8.2



VETS-100A Reporting - Functional



In accordance with Title 38, United States Code, Section 4212(d), the U.S. Department of Labor (DOL), Veterans' Employment and Training Service (VETS) collects and compiles data on the Federal Contractor Program Veterans' Employment Report (VETS-100 Report). This data is collected from Federal contractors and subcontractors who receive Federal contracts that meet the threshold amount of \$25,000 or more prior to December 1, 2003 or \$100,000 on or after December 1, 2003. The VETS-100/100A reporting cycle begins annually on August 1 and ends on September 30.

For 2009, institutions required the option of filing two reports, VETS-100 and VETS-100A, to the U.S. Department of Labor regarding the annual Report on Veteran's Employment. The new report, the VETS-100A, has been designated for 2009. This report will be used for those sites that are working under covered Federal contracts entered into or modified on or after December 1, 2003. This new report is due on September 30 of each year. If the employer has Federal contracts that were entered into before December 1, 2003, the VETS-100 report has to be filed. This report retains the same format as before and is also due annually on the September 30 date. Both reports are being generated by a new Java program provided in this release, and the user can determine which report will be generated based on the parameters that are submitted for the run. Detailed information on the report and its submission can be found on the U.S. DOL website <https://vets100.vets.dol.gov/>.

An additional feature provided with this release is a separate audit report that details employees that qualify for reporting and are being counted for the appropriate Job Category. Job Categories are determined by an employee's Primary Job assignment and the EEO Skill Code that is attached to the corresponding Position Classification.

It is important to note that Banner-supported Higher Education Job Categories, also used for the annual IPEDS reporting cycle, do not exactly match the commercial-oriented Job Categories as specified on the VETS-100/100A formats. Therefore, your reporting official should carefully review the report tabulations and determine which categories best represent the Job Categories being requested by the DOL.

A new Job Category, First or Middle Level Official or Manager for VETS-100A, has been added to Position Class Rule and History forms (NTRPCLS and NBICLSH) to support a new Job Category and report appropriate headcount for these employees. This new job category signifies the classification that represents first and middle-level officials and managers within your organization.

As a planning activity, it is important to determine which employees and their affiliated Position Classifications may need to be reported in this new category and set the new

indicator appropriately on NTRPCLS. In addition, ensure that the Classification Change Date that appears when the record is saved is dated properly and falls within your planned Start and End Dates that will be used for the report period.

Reports

Veterans Employment Report (PERV100)

This program generates a report that can be used to complete the Federal Contractor Veterans' Employment Report (VETS-100 and VETS-100A) for U.S. institutions. This report lists by skill code the counts of Special Disabled Veterans, Vietnam Veterans, Other Protected Veterans, Armed Forces Service Medal Veterans, and Recently Separated Veterans, both currently employed and newly hired within the specified period. This report is a Java report.



Note

The report does *not* count employees when an EEO skill code of 90 (Other) on the Position Class Rule Form (NTRPCLS) associated with their positions. ■

Calculation of Minimum and Maximum Figures in Report Summary Lines

In an effort to tabulate the totals for the year, the report determines the number of employees that are active or on leave based on the Start Date parameter for the report. In order to determine these figures, the program performs these actions:

The minimum and the maximum number of employees hired are now calculated and printed for the period identified by the Start Date and the Stop Date.

- Specify the Report Parameters 01 and 02, Start Date and Stop Date to determine the period for which the report is being generated.
- Specify Report Parameter 03, Hiring Location, to identify the employee population.
- Only those pay periods that fall within the dates specified for the Start Date and Stop Date parameters will be considered.
- Employees are counted only once in each pay period, across all Pay IDs and is based upon their Primary Job assignment.
- The number of employees per pay period is calculated for all pay periods.
- Temporary employees or those with Employee Skill code 90 are excluded from the total counts.
- The smallest and the largest number of *permanent* employees per pay period is printed for the Minimum and the Maximum number of employees, respectively.
